That I, JOVENMARLO ADAP IMPERIO, of legal age, Filipino, and residing at Pastoral House, Seventh-day Adventist Church, Sitio Pacil Brgy. Pawa Masbate City 5400 Masbate, Philippines, have decided to form a corporation sole, under the laws of the Republic of the Philippines.

ARTICLE I – NAME

The name of this corporation shall be H4J Homes for Jesus Community Inc.

ARTICLE II – PURPOSE

The purpose for which this corporation is formed is to establish and operate a non-stock, non-profit religious organization to:

1. Propagate the Christian faith and values.
2. Provide homes and support for individuals in need.
3. Conduct religious, educational, and charitable activities.
4. Operate various ministries and programs under the umbrella of Global Frontiers Institute.

Establishment of Other Field Offices: The corporation may establish other field offices in any city or municipality within the Philippines and abroad. The Masbate Mission Field Office shall serve as the coordinating office for organizing local Homes for Jesus communities and for organizing care groups, ministry groups, community outreach, and evangelistic efforts in partnership with the local congregation(s) of The Seventh-day Adventist Church.

ARTICLE IV – INCORPORATOR

The name, citizenship, and residence of the corporation sole is:

Jovenmarlo Adap Imperio, Filipino, residing at Pastoral House, Seventh-day Adventist Church, Sitio Pacil Brgy. Pawa Masbate City 5400 Masbate, Philippines

ARTICLE V – TERM

The term for which this corporation is to exist is perpetual.

ARTICLE VI – POWERS

This corporation shall have all the powers granted by law, including the power to solicit and receive donations, contributions, and bequests; to acquire, hold, and dispose of real and personal property; to enter into contracts; and to perform all other acts necessary or convenient to carry out its purposes.

ARTICLE VII – GOVERNING STRUCTURE

The corporation shall be governed by the following structure, with the Corporation Sole retaining ultimate authority:

Corporation Sole (Jovenmarlo Adap Imperio): Serves as the single legal head, with authority to manage affairs, execute policies, and make final decisions.

Advisory Council: A body of 5–7 members with expertise in religious ministry, education, healthcare, finance, and legal matters, providing non-binding strategic advice and oversight.

Executive Director: Appointed by the Corporation Sole to oversee day-to-day operations, coordinate ministries/programs, and manage staff.

Ministry/Program Heads: Dedicated leaders for each named ministry/program, responsible for planning, implementation, and reporting.

Support Departments:

- **Finance Department:** Manages budgeting, accounting, and compliance.
- **Administrative Department:** Handles human resources and logistics.
- **Communications Department:** Coordinates marketing and outreach.

Local Chapters (As Needed): Established in regions to implement programs locally, under the oversight of the Executive Director.

ARTICLE IX – PARTNERSHIP WITH THE SEVENTH-DAY ADVENTIST CHURCH

1. Harmony with Faith and Practice: All programs, ministries, and events of H4J Homes for Jesus Community Inc. shall be conducted in full harmony

- with the principles of faith and practice of the Seventh-day Adventist Church, as outlined in its official statements and doctrines.
2. Respect for Organizational Authority: The corporation shall respect the established organizational structure of authority of the Seventh-day Adventist Church, from the General Conference down to the local church.
 3. Roles of Participating Individuals:
 - Individual Members: Participate in programs, uphold Adventist beliefs, and support ministry activities.
 - Pastors: Provide spiritual guidance, oversight of religious activities, and pastoral care to participants.
 - Volunteer Organizers: Plan and execute events, coordinate logistics, and ensure alignment with Adventist principles.
 - Care Group Leaders: Facilitate small group Bible studies, nurture spiritual growth, and connect members to the local church.
 4. Role of Local Mission/Conference: Provide pastoral supervision, approve local programs, and ensure alignment with the conference's mission and policies.
 5. Role of Union Mission/Conference: Oversee regional coordination, provide strategic guidance, and ensure consistency with the union's objectives and Adventist doctrine.

ARTICLE X – AMENDMENTS

These Articles of Incorporation may be amended by the Corporation Sole, in accordance with the Corporation Code of the Philippines.
